Your online services

When the portdegrimaud.fr website was created, a user portal was created in order to be able to settle your administrative requests in a dematerialized manner. This space is dedicated to all Port users: stopovers, annuals and former lessees. You can make a stopover request online, pay your bills, report movements on your mooring, etc. As soon as all the data has been entered by the harbor master's office, you will be able to find all your information related to your experience with the port.

"Régie du port": a privileged model of port management

By decision of the City Council, it is now a municipal company that manages Port Grimaud. This model is not specific to Grimaud, on the contrary. In order to improve service to users, many municipalities and public administrations in France have decided to select the management with "Régie". This is the case in Cogolin, Villefranche sur mer, Deauville, or Solenzara. Many examples on the French coast for the greatest satisfaction of boaters and owners. Of course, this model is set up with great concern for adaptation to the specificity of Port Grimaud.

TRUE OR FALSE

My previous contract remains in force until the initial date of the end of the concessions?

FALSE – The farm-out contracts that were signed previously provided for a contract termination clause in the event of the end of the concessions (art .9 to PG1, art.7 to PG2 and art.10 to PG3). The presence of these clauses clarifies the situation, unlike the «Propriano» case judged by the Council of

State and whose contracts did not provide for this hypothesis.

If I don't have a contract in 2022, it won't be possible for me to sign a 35-year contract from next year?

TRUE – The possibility of signing the guarantee of use contract for 35 years will only be possible if there is legal continuity between the old farm-out contracts and the guarantee of use contract. Without justification of the title of occupation of the body of water for one year, it will become

more difficult to justify the request.

Has the municipality lost its lawsuits against the former delegates?

FAUX – The municipality had asked for recognition of the urgent nature of some of these requests in order to limit the duration of some of the twenty or so disputes brought by the various delegates. The Toulon administrative court did not recognize the urgency of the requests. It is therefore by the classic procedure before the administrative court that the files will be judged.
